DR. LARRY JOHNSON



Dr. Johnson started his career with The City of New York as a Casemanager with the Administration for Children Services. He was employed with the Administration for Children Services for 9 years delivering preventive services to children and families. He then transferred to the New York City Department of Correction as an Associate Correctional Counselor. He then was responsible for assisting inmates with re-entry into the community and overseeing discharge planning outcomes. He was promoted to supervise the NYC Department of Correction Information Technology Helpdesk/Inmate Information System. He supervised the day-to day activities of a 24x7 IT-Helpdesk that provides Level 1 technical support. He was responsible for implementing E311 Inmate Look-up Service, a service that provides inmate information to the public and provides inmates with information to community based programs. He then accepted a position as Section Supervisor of the CityTime Management Unit, a newly created unit within the NYC Department of Correction Human Resource Division. He is responsible for the implementation of CityTime, a secure web-based time and attendance system that employees will use for recording time, overtime, and requesting leave. The system provides objective and consistent application of the citywide compensation rules and policies as defined by collective bargaining agreements.

Dr. Johnson is an Adjunct professor at Empire State College. He teaches Introduction to Criminal Justice and Introduction to Law Enforcement to students seeking opportunities in the criminal justice field. He received his education in the New York City public school system, graduating from Park West H.S specializing in Culinary Arts. He earned a Bachelor of Arts Degree in Political Science from Fisk University. He received his Commission as 2nd Lieutenant from Vanderbilt University's R.O.T.C program and served with the United States Army National Guard for 3 years. He earned a Master of Human Services Degree from Lincoln University. He earned a Doctorate degree in Education from Fielding Graduate University.

Dr. Johnson is Treasurer of the NYC Correction Guardians Association, Inc. NYC Correction Guardians Association, Inc is non-for-profit organization that provides mentorship, networking, community service, and resolving unethical or discriminatory treatment of African-American uniform and civilian employees. He serves on the Board of Directors of New York Therapeutic Communities, Inc. New York Therapeutic Communities, Inc is a not-for profit organization providing substance abuse treatment primarily to adults in the criminal justice system. The community-based residential programs enable those involved in the criminal justice system to prepare themselves to re-enter society. He is a graduate of the Bronx Clergy Criminal Justice Re-Entry and Youth Crime Prevention Training Program and serves as a mentor with the Bronx Clergy Criminal Justice/ Fedcap to provide young women and men placed on probation with resources to become functional members of the community.

Dr. Johnson is the Executive Director of Salvation Baptist Church Men and Social Ministry. He is a member of Alpha Phi Alpha Fraternity, Inc.
